

PHOTOGRAPHY POLICY

PURPOSE

12x12 Gymnastics Ballina Inc. (12x12) is committed to providing the highest levels of membership service. This includes protecting members' privacy, promotion of positive behaviours and protecting the health safety and wellbeing of members.

By introducing policy and procedures regarding the taking and use of photographs and filming, this policy reiterates 12x12 commitment to its members.

This Policy applies the 12x12 Privacy Policy to the taking of, and use of photography, with particular reference to the 12x12 website, 12x12 print publications and photographs taken at 12x12 Gymnastics Ballina Inc.

DESCRIPTION

Photography includes but is not limited to still camera, mobile phone photos and any form of still captured images. Filming includes but is not limited to video, mobile phone video, DVD and any form of moving captured images.

This policy applies to participants, spectators, coaches and staff at all 12x12 activities.

PROCEDURE FOR OBTAINING PERMISSION TO TAKE PHOTOGRAPHS AND FILM GYMNASTS

When registering for membership of 12x12 parents/guardians are required to give or decline permission to photograph or film the gymnast.

12x12 will also verbally advise all parents/guardians, coaches and gymnasts that photographs will be taken prior to the class or activity taking place.

If formally notified by a member that they do not wish to have their image captured 12x12 will endeavour to respect the member's wishes, but is not directly responsible for the taking of images.

AUTHORISED PHOTOGRAPHERS

Only 12x12 authorised photographers and videographers are permitted to take photographs or film on at 12X12 Gymnastics activities.

PARENTS AND SPECTATORS

12x12 permits parents, guardians and immediate family members to take photographs and video from the spectator areas only, and of their gymnast only.

NON-PERMITTED LENS TYPES

With the exception of authorised photographers, digital SLR cameras and/or lenses of a professional standard cannot be used within the confines of any 12x12 venue.



GUIDELINES FOR THE USE OF IMAGES

12x12 will endeavour to ensure that photographs and videos are only published on the 12x12 website and social media.

HEALTH AND WELLBEING

12x12 is concerned with the health and wellbeing of its members, and as such will exclude images that may be deemed offensive or unflattering.

12x12 will not identify persons will full names in a published image unless written approval has been obtained.

OWNERSHIP OF IMAGES

Any images collected by 12x12 are the property of the Association and individuals contained in such images has no ownership rights of such images. 12x12 retains the right to use members' images in publications and promotional material.
